Dues payments to the HBCA of Brevard are NOT tax-deductible as charitable contributions for federal tax purposes, but may be deductible as ordinary and necessary business expense. A portion of your dues to the FHBA is used for lobbying and is not deductible for tax purposes. The non-deductible portion of your FHBA dues is 28% and the non-deductible portion of your NAHB dues is 19%.

**Builders and Associates:** Your dues for your annual membership to the HBCA of Brevard include \$115 for membership in the Florida Home Builders Association (FHBA) and \$198 for membership in the National Association of Home Builders (NAHB). \$10.00 of your dues for membership in the Florida Home Builders Association and \$5 of your dues for the HBCA of Brevard is allocated to the Florida Home Builders Political Action Committees. This portion of your dues is not tax deductible as a business expense. This allocation is optional.
